Downy mildew is distinctly different from powdery mildew in several areas. The topside of the leaf is usually yellow and blotchy and, in some cases, has very angular patterns that follow the lines of veins. On the underside of the leaf are small, dark green/grey patches of downy growth. The three main downy mildew species that affect nursery stock are Peronospora, Plasmopara and Bremia.
